
Dear Richard:


This is a very limited letter of reference which is being issued at the request of Mr. Brenneke. It is intended only to verify employment and Mr. Brenneke's flying license qualifications.

In regard to the items you discussed with me.

(A) A telefax regarding the Yamaha motors was sent to Yassari today with all of the information he requested. A copy is enclosed for your reference. I did not quote the prices as you can see. I understand that you gave him the price on these.

(B) Whom do you wish me to send the TNT specifications and delivery information to?

(C) With regard to your other requests:

(1) Mortar shells - 81 mm.

Factory specifications are enclosed for these. Do your people want HE or PWP Smoke type? I will secure prices if your people are serious.

Mortar Shells 121 mm.

After talking with several manufacturers I cannot find any 121 mm shells. They are not manufactured. 120mm and 122mm are manufactured and available. Please let me know what your people want and ask them to be more precise.

(2) 175 Howitzer.

Information on this is attached. Please let me know if your people are interested. Since these are no longer manufactured I do not know if I can obtain them. I do not want to spend the time looking unless there is a serious interest.

(3) Telescope or camera for F4 Mod RF4KW240E.

I do not have access to these.

Your people may be interested in Mk IV cannons in pods, with snares, for the F4. Cost FOB factory is approximately \$200,000 per unit. At this date 55 units are available. If your people are interested I would need further specific information from them.

(4) Radar Lamp WS12.

I do not have access to these.

Sorry I could not talk further Tuesday when you called. Believe it or not, I do have other people to speak with and other things to do.




